

Significant Weather:



Special Weather Statement - Northwest Arctic Coast; Northern Arctic Coast; Central Beaufort Sea Coast; Eastern Beaufort Sea Coast; Western Arctic Plains; Howard Pass and the Delong Mountains; Central Arctic Plains; Central Brooks Range; Romanzof Mountains - Accumulating wet snow continues through Friday morning. Accumulations up to 4 inches expected for most of the Arctic Plains, with totals of 4-8 inches in the Brooks Range.

Dense Fog Advisory - **Fairbanks Metro Area:** Visibility of one quarter mile or less, until 10AM this morning.

Winter Weather Advisory - **Northern Denali Borough; Southern Denali Borough:** Snow expected with accumulations up to 2-4 inches, in effect from 10pm this evening to 7am Saturday.

Flood Advisory - Western Susitna Valley; Southern Susitna Valley; Central Susitna Valley: Yentna River near Lake Creek, flooding caused by excessive rainfall is expected to cause the river to reach minor flood stage by late Thursday evening, with a crest expected late Friday morning.
