

Special Weather Statement - City and Borough of Yakutat; Municipality of Skagway; Haines Borough and Klukwan; Glacier Bay; Eastern Chichagof Island; Cape Fairweather to Lisianski Strait; City and Borough of Sitka; Admiralty Island; City and Borough of Juneau; Petersburg Borough; Western Kupreanof and Kuiu Island; Prince of Wales Island; City and Borough of Wrangell; Ketchikan Gateway Borough; City of Hyder; Annette Island: Another round of moderate to heavier rainfall expected early next week across the panhandle.

Special Weather Statement – Kodiak Island Southwest: Resuspended ash from KATMAI-NOVARUPTA expected over southern Kodiak Island through Friday Morning.

Dense Fog Advisory - Petersburg Borough and Price of Wales Island: Visibility of one quarter mile or less, until 10AM this morning.

Winter Weather Advisory - Northern Denali Borough; Southern Denali Borough: Snow expected with accumulations up to 2-4 inches, in effect from till noon Saturday.
