Typhoon Halong: West Coast Storm: *See Attachments

Congregate sheltering in Anchorage and Bethel have closed with all sheltering families and individuals having transferred into non-congregate sheltering. Services for evacuees having previously been provided at the Egan Convention Center will be shifted to the Spenard Community Recreation Center. A disaster assistance center (DAC) has opened to assist survivors of the West Coast Storm and connect them to services. See the link in Public Information below for more information.

SEOC Preparedness Level:

SEOC has gone from Level 4 to Level 3 Preparedness in the ongoing transition from response to recovery. State, FEMA, EMAC, and all partners will continue to focus on the disaster.

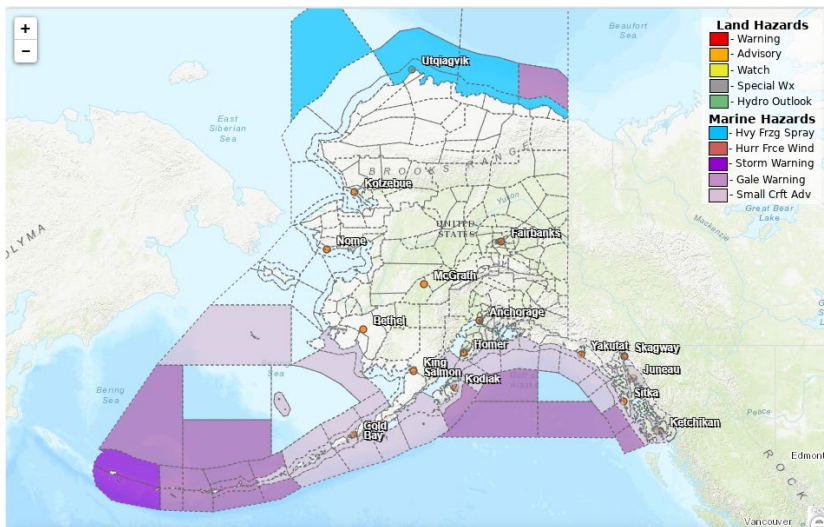
