Mail pick-up services will continue at the Egan Center through the end of November. Bethel DAC has been extended through Friday, November 21. SEOC team members are providing ongoing support at the EOC, and Joint Field Office (JFO).

Emerging Incidents: Bering Sea Storm Forecast

State and federal teams continue to monitor conditions closely as storm systems move through the region into mid-week. Noting that while the overall risk of major coastal inundation appears reduced compared to earlier projections, elevated water levels remain possible in portions of Southwest Alaska. Favorable low-tide timing and current wind direction may help limit impacts; however, the active storm pattern is still expected to bring strong winds, snow, and mixed precipitation that may interrupt operations.



Winter Storm Warning: Southern Seward Peninsula Coast; Interior Seward Peninsula - Winter Storm Warning in effect from 3 AM Monday to 3 PM Wednesday.

Shishmaref; Bering Strait Coast - Winter Storm Warning in effect from 9 AM Monday to 3 PM Wednesday.

St. Lawrence Island - Winter Storm Warning in effect from 9 PM this evening to 3 PM Wednesday.

Winter Weather Advisories: Municipality of Skagway - Winter Weather Advisory remains in effect until 6 PM this evening.

East Turnagain Arm - Winter Weather Advisory is now in effect until 9 AM this morning.

Eastern Norton Sound and Nulato Hills; Yukon Delta Coast; Lower Yukon River - Winter Weather Advisory in effect until 3 PM Wednesday.

Noatak Valley; Kivalina and Red Dog Dock; Lower Kobuk Valley; Baldwin Peninsula; Northern Seward Peninsula; Upper Kobuk Valleys – Winter Weather Advisory in effect from 9 AM Monday to 3 PM Wednesday.
