Adak - Power Disruptions

Adak reported power disruptions today during heavy snow and blizzard conditions. City is actively working to restore power. Adak has an SEOC deployed generator installed to allow continued airport navigation system operation during power failures.



High Wind Watch - Valdez and Thompson Pass.


ADVISORIES:

Valdez Avalanche Center – Maritime, Intermountain, Continental - Low at all elevations.
