Tok Mukluk Fire

Acres: 7,335

Containment: 29%

Location: Tok, AK

Start Date: Aug. 17, 2026

Fuels: Black Spruce, Shrubs, Grass

Suppression-repair activities continue under an approved repair plan, including restoration of dozer lines and ATV trails south of Red Fox Drive. Firefighters have completed equipment backhaul and continue monitoring containment lines and hot spots. Residents are reminded to use caution around burned areas and debris. DFFP has extended the fire season in the Delta, Tok, and Copper River protection areas through September 14 due to continued dry conditions and elevated wildfire risk. Cool, wet weather is limiting fire activity, although some smoldering may continue in deep organic soils and heavy fuels.

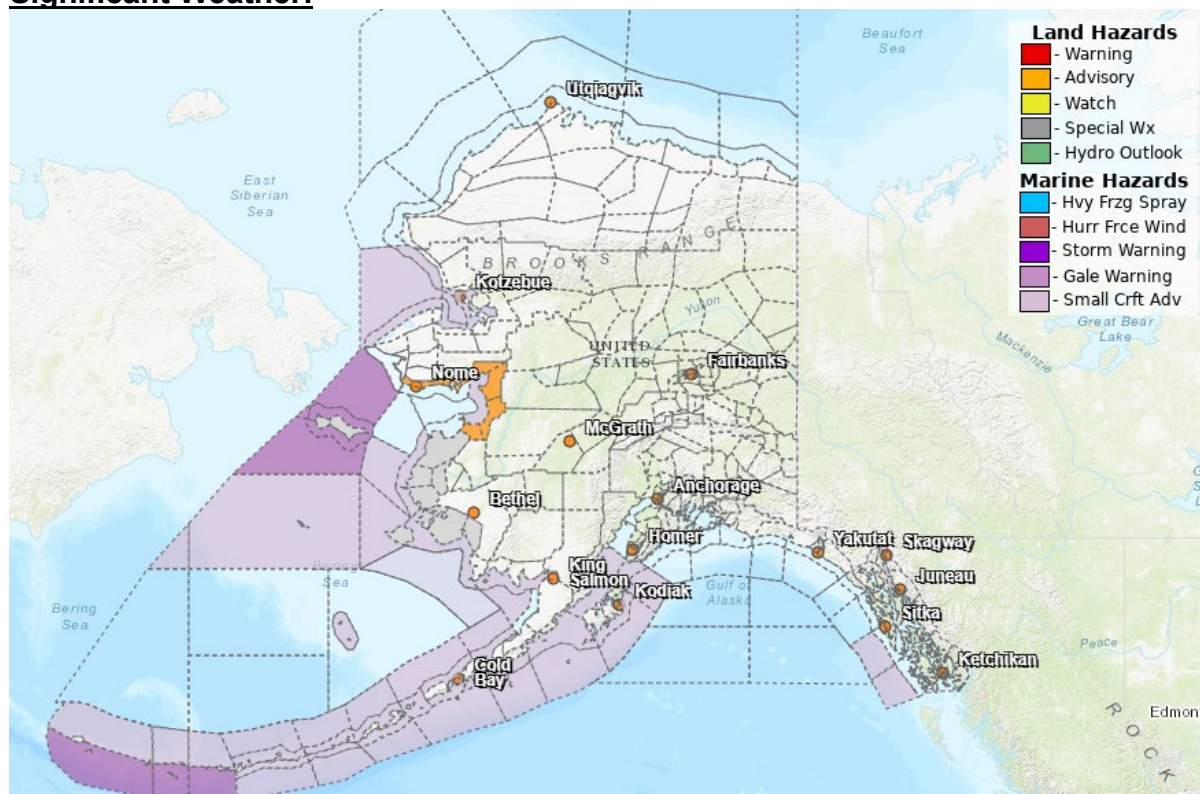
