#### Significant Issues:

Governor Dunleavy has declared a disaster for the Kuskokwim River communities in the Lower Kuskokwim and Yupiit Regional Education Attendance Areas in response to flooding. The disaster recovery Individual Assistance program, that provides grant funding to individuals and families with damaged to primary residence or essential personal property lost during the flooding, is now open for those in the declared area.

#### **Riverwatch:**

With the end of breakup flood risk on the Upper and Middle Yukon River segments and Kuskokwim River, SEOC has demobilized Riverwatch aerial operations. Breakup on the Lower Yukon River is still a few days away and SEOC conducted a community call with area communities this week to brief them on conditions.

SEOC is actively monitoring all other flood concerns and will engage with communities as needed.

# Fort Yukon Communities Snowmelt Flood Concern:

There is concern for snowmelt flood concern for Alaska's Yukon communities in and around Fort Yukon in 5 to 11 days from snowmelt through Canadian Old Crow and Porcupine Rivers. SEOC and National Weather Service are in direct contact with Canadian officials and are carefully monitoring.

# Kuskokwim Division:

Division will complete transition from response to recovery today and demobilize. Disaster recovery operations will continue remotely from SEOC and Recovery personnel will deploy to communities as required.

Division coordinated Alaska Department of Environmental Conservation technical assistance for Kwethluk and Napaskiak for environmental concerns.


Division coordinated with Red Cross to assist a flooded resident in Bethel.

SEOC coordinated Yukon Kuskokwim Health Corporation, Red Cross, and state disaster Individual Assistance for a flooded resident in Nightmute yesterday.

#### Wainwright Power Outage:

North Slope Borough contacted SEOC last night and reported a community-wide power outage in Wainwright. The outage was caused by equipment failure due to a glycol leak. The Borough deployed repair personnel to the community who were unable to make immediate repairs. SEOC worked through the night with the Borough and Alaska Energy Authority to assist the community. Police, Fire, School, Clinic, and General Store are running on independent power generators. The Borough declared a local disaster emergency to allow local response operations. As of this report, the Borough is arranging delivery of generators and preparing the school as a shelter. SEOC has contacted the Red Cross and School District and is regular contact with Borough Emergency Management.
